Involving Single Dog Entries

Veterans Classes*: Classes for dogs & bitches 7 years & under 10 years, 10 years and under 12 years and 12 years and over. Sexes divided.

*Chapter 11, Section 8 of the Rules Applying to Dog Shows allows spayed bitches and castrated dogs to be shown in the Veterans classes at Independent Specialties.

Hunting Retriever Classes: Classes for dogs & bitches that have earned an AKC Junior, Senior or Master Hunter title under AKC rules. May not be spayed or neutered. Sexes divided.

Field Trial Classes: Classes for dogs & bitches that have won, placed or received a judge's award of merit in any AKC licensed or member field trial. May not be spayed or neutered. Sexes divided.

JUNIOR SHOWMANSHIP

Junior Showmanship offered 6 times!

Thursday PM, Friday AM & PM, Saturday AM & PM & Sunday

Novice Class

For boys and girls at least 9 and under 18 years of age on the day of the show who at the time entries close, have not won three first places with competition present in a Novice Class at a licensed or member show. A Best Junior win with competition counts as one win toward moving to Open.

Open Class

For boys and girls at least 9 and under 18 years of age on the day of the show who at the time entries close, have won three first places with competition present in a Novice Class at a licensed or member show.

Master Class

This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

Best Junior Handler & Reserve Best Junior Handler

Junior Handlers must include their AKC Junior Handler Number on each entry. You may obtain your junior identification number by calling the AKC at (919) 233-9767. Be sure all information for Junior classes is entered on the front and back of the entry form.

Bitches in season are not eligible. At Specialty shows, dog must be of the breed for which the show is held.

Puppy, Veteran & Gun Dog Sweepstakes

Sweepstakes offered Sunday only

Sweepstakes entry fee is \$25.00

(Puppy Sweepstakes entry must also be entered in the regular class at the Sunday show.)

The entry fees will be divided as follows: The club will retain 35% to cover expenses.

Best in Puppy / Veteran Sweepstakes 20 %
Best of Opposite Sex to Best Puppy / Veteran in Sweepstakes 15 %

PUPPY SWEEPSTAKES

Sweepstakes are open to Golden Retrievers 6 months and under 18 months. Each entry must also be entered in the Regular Class at the CVGRC Sunday show. Champions of Record are NOT eligible to compete. Indicate Sweepstakes on the regular entry form in the space for additional classes (state age).

PUPPY CLASSES (for Dogs and Bitches)

Puppy, 6 months and under 9 months
Puppy, 9 months and under 12 months
Junior, 12 months and under 15 months
Junior, 15 months and under 18 months

VETERAN SWEEPSTAKES

Veteran Sweepstakes are open to dogs and bitches 7 years and older. Veterans Sweeps entries need NOT be entered in the Regular Classes at this show. Champions of record are eligible as are spayed and neutered Golden Retrievers. Indicate Sweepstakes on the regular entry form in the space for additional classes (state age).

VETERAN CLASSES (for Dogs and Bitches)

7 years old and under 10 years
10 years old and under 12 years
12 years and older

The handler of a Puppy or Veteran Sweepstakes exhibit must be either the owner, co-owner, breeder or member of their immediate family as they are listed on file with the American Kennel Club as of the closing date.

Professional handlers are not permitted to exhibit in this class. (A professional handler is here defined as any person who receives money, or any other form of compensation, service or considerations, for handling an exhibit not owned by them or a member of their immediate family.)

Disabled or physically challenged handlers are encouraged to show their own dogs and every effort will be made to accommodate them.

GUN DOG SWEEPSTAKES

Gun Dog Sweepstakes are open to dogs and bitches with an AKC Hunting Title, ** or *** designation earned in an AKC Retriever Field Trial. Gun Dog Sweeps entries need NOT be entered in the Regular Classes at this show. Champions of record are eligible as are spayed and neutered Golden Retrievers. Indicate Gun Dog Sweepstakes on the regular entry form in the space for additional classes (state division).

GUN DOG CLASSES (for Dogs and Bitches)

Junior Hunter – For dogs that have earned the AKC Junior Hunter Title
Senior Hunter – For dogs that have earned the AKC Senior Hunter Title
Master Hunter – For dogs that have earned the AKC Master Hunter Title

HANDLER QUALIFICATIONS: There are no requirements for the handler of the Gun Dog Sweeps. Anyone can handle any dog in the Gun Dog Sweeps.

4-6 Month Beginner Puppy Competition

4-6 Month Beginner Puppy offered once each day on Thursday, Friday & Saturday

One combined class, not divided by sex, will be offered for Golden Retrievers that are at least four months and under six months of age on the day of the competition. All of the puppies are exhibited in the same class and the only placements are Best of Breed (BOB) and Best of Opposite Sex to Best of Breed (BOS).

Entry and eligibility requirements:

• AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the *Rules Applying to Dog Shows*. A foreign born dog may enter this class if they are registered in the country of origin.

• All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.

• Professional handlers, members of their household and current assistants to professional handlers may not personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition. Dogs that are owned or co-owned by the forenamed may compete in this competition, but must be handled by a non-professional handler. (*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.*) Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.

(Option 2* - All Breed/All-American Rally)

4 trials total offered: 2 on Thursday, 2 on Friday

Offered Rally Classes:

Novice A, Novice B, Intermediate, Advanced A, Advanced B, Excellent A, Excellent B, Master

***Option 2:** We will accept entries for Golden Retrievers first, then accept entries from all other breeds until the entry limit specified is reached (in the order they are received). Exhibitors entering a breed other than a Golden Retriever will be notified as soon as possible after the closing date regarding the status of their entry. Entries are open to All-American/Mixed Breed dogs listed in the AKC Canine Partners program.

RAE & RACH entries:

Please check the box on the entry form for RAE or RACH (rally). Dogs entered in this class will be entered in both Excellent B and Advanced B (rally RAE) or Excellent B, Advanced B and Master (rally RACH). Once the limit has been reached in either class, any subsequent RAE or RACH entries will be returned in their entirety.

Rally Bitch in Season Refunds: The Club will refund 50% of the entry fee for bitches unable to compete for that reason. All refund requests must be accompanied by a dated, signed letter on official business letterhead from your veterinarian stating the reason that your dog cannot compete. Text e-mails, phone calls and non-letterhead notes will not be considered. All requests must be received by the Show Secretary by 12:00 p.m. on the day of the show. Refunds are for bitches in season *only.*

Rally transfers will be permitted in accordance with Rally Regulations, Chapter 1, Section 16. The request to transfer must be presented in writing to the Show Secretary at least 30 minutes prior to the start of each trial.

All Rally classes will be run in jump-height order from Small-Tall. Please include your jump height on the entry form.

All rally entries must indicate class "A" or "B" and/or jump height where required.

If a dog is entered in both Conformation and Rally, you must pay the fee for the first entry of the dog in EACH trial, as they are separate events.

Rally ribbon prizes will be offered as specified in Chapter 1, Section 1 and Sections 28-32 of the Rally Regulations. Qualifying score required for all prizes offered in the Rally classes.

**Judges' Award of Merit. This award is given at the discretion of the Judge and will be awarded to outstanding entries that are not judged to be Best of Breed, Best of Opposite Sex, Best of Winners, Select Dog or Select Bitch. (As a Judges' Award of Merit is a club award and the Select is an official award of the AKC, the Select is of greater precedence than the Award of Merit.) All other dogs remaining in the competition are eligible. The number of awards will be up to 10% of the Best of Breed entry.*

CATALOGS: A very limited number of catalogs will be available for sale on-site. You are encouraged to pre-order/pre-pay your show catalog. Pre-order price: \$6.00. Price on-site: \$8.00.

Dogs need to be at the show only at the scheduled time of judging and may leave immediately thereafter unless required for further judging. The judge is not required to wait for dogs. It is the responsibility of the owner or handler to have the dog at ringside when required and without being called.

Please keep the area cleaned up with the equipment provided. If we are to have access to these facilities again, exhibitors and handlers MUST keep them clean. There will be no smoking inside the pavilion. Please dispose of trash in the proper manner.

Parents must be responsible for children. Children must be kept under supervision at all times. No strollers please, for the safety of your child.

The use of flexi-leads is not prohibited on show grounds. However, we urge you to use them responsibly.

Free admission/Free parking. See special RV Parking information in premium.

No gasoline or diesel generators inside any building or within 100 feet of any area in which this dog show is conducted.

All dogs present must be on leash or confined to their crates except when being judged.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Telegraph, telephone and unsigned entries cannot be accepted. Entries not on an official AKC entry form and photocopies of entry forms without agreement and rules on the back of the official AKC entry form are NOT ACCEPTABLE. Entries received without fees, postdated checks, returned checks or declined credit cards do not constitute a valid entry fee. The Show Secretary will add a \$30 collection fee to the amount of each returned check. Refunds of \$8 or less will not be issued due to the cost of processing.

PLEASE make your entries correct and legible. Illegible entries cannot be processed and will be returned to the exhibitor. Owners/Agents are responsible for errors on entry forms. (Rules Applying to Dog Shows, Chapter 11, Section 6). Each Owner/Agent listed on the entry form and/or individual responsible for the dog at the show is bound by the Certification and Agreement on the front and back of the entry form regardless of who may have completed and submitted the form. No entry fee will be refunded in event of such errors, or cancellation of entries after the published closing date. No refund for duplicate entries. No entry will be accepted which specifies any conditions as to its acceptance.

An AKC Recording Fee of \$.50 first entry only and an AKC Event Service Fee of \$3.00 per entry will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. An AKC Recording Fee of \$3.50 will be required for each first entry, \$3.00 for each additional entry in any Licensed or Member Club Rally Trial. All Recording and Event Service Fees are paid to the American Kennel Club. There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes or Special Attractions. (Rules Applying to Dog Shows, Chapter 11, Section 2)

Entry fees will not be refunded in the event that a dog is absent, disqualified, or excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee. If because of riots, civil disturbances, or other acts beyond the control of the show giving club, it is impossible to open or complete the show, no refunds will be made.

No entry may be changed or canceled unless notice of the change or cancellation is received in writing by the Show Secretary prior to the closing date and hour for entries, except that a correction may be made in the sex of a dog, or a dog may be transferred from one division of the Puppy Class to another or between the Puppy and Twelve-to-Eighteen Month Class at a show prior to the judging. A dog determined to be ineligible, by its owner/agent, for the class in which it has been entered may be transferred to an eligible open class at a show prior to the judging of any regular conformation class within the sex of that breed or variety, and that dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for a show but whose Championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety competition, provided this transfer is made by the Superintendent or Show Secretary at least one half-hour prior to the scheduled start of any regular conformation judging at the show. No dog may otherwise be transferred to another class. Owners are responsible for errors in the entry forms, regardless of who may make such errors.

The host clubs, the Show Secretary, or their members or agents assume no responsibility for any loss, damage, illness or injury sustained by exhibitors, handlers or to any of their dogs or property; and further assume no responsibility for any injury to children in attendance.
